

SUDHANSHU BATRA

General Biography

Mr. Sudhanshu Batra is a Senior Advocate, Mediator and Trainer. He joined the Bar in the year 1986 and has practised in all courts in Delhi and across the Country. He was designated Senior Counsel in the year 2010. He has been a Mediator with Samadhan, the Delhi High Court Mediation and Conciliation Centre since its inception in the year 2006. He served as the Organising Secretary of Samadhan for about six and half years from 2011. He is empanelled with the Singapore International Mediation Centre (SIMC). He is also a founding member of Maadhyam, a society for Conflict Resolution and as a Vice President of the said society. He is also a member of the PHD Chamber of Commerce and Industries. Presently, he is an elected Executive Member (Senior Designated) with the Delhi High Court Bar Association. He is empanelled as an Arbitrator at the Delhi International Arbitration Centre.

Mr. Batra has practised in varied fields of law including company matters, civil matters, arbitration matters, rent matters, Intellectual Property disputes, consumer disputes, family disputes and matrimonial disputes amongst others. He has also appeared in several writ jurisdiction matters at the High Courts and the Supreme Court of India. He has also been an Arbitrator in several matters and is often appointed as a Sole Arbitrator by the High Court and the Delhi International Arbitration Centre.
